- Article II. One Person from the outing is to serve as the liaison between your outing and Timberlin Golf Club Tournament Director.
- Article III. **No personal coolers will be allowed on the course.** No Exceptions.
- Article IV. Proper Dress is required.
- Article V. We will supply a maximum # of 68 carts for play, this totals enough for 136 players. If you wish to have more than 136 players, the outing can add players with the option for them to walk. Cart fee for walking players will not be charged. Walking option is only available once the 68-cart cap is reached. We do not have an option to rent additional carts. Maintenance equipment use for outings is at the discretion of the Director of Golf.
- Article VI. 5 days prior to your outing, contact Timberlin Golf Club tournament director with final number of players in your event.
- Article VII. The contract balance will be paid in full within 1-week of the event. No exceptions. Payment is accepted in the form of cash or check (payable to Town of Berlin).
